

SUMMARY ANNUAL REPORT FOR GUM GUM, INC. EMPLOYEE BENEFITS PLAN

This is a summary of the annual report of the Gum Gum, Inc. Employee Benefits Plan (Employer Identification Number 26-1276256, Plan Number 501) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Gum Gum, Inc. has committed itself to pay certain medical, dental and vision claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Guardian, United Healthcare Insurance Company, ComPysch, Pre-Paid Legal Services Inc dba LegalShield, Hartford Life and Accident and Delta Dental of California to pay certain life, accidental death & dismemberment, medical, dental, vision, temporary disability, legal, long-term disability, business travel accident, employee assistance and accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$2,689,528.
